Pailan College of Management & Technology (B.Ed.Section) (Self-Financed) is hereby accorded the provisional affiliation for three (3) years with effect from the academic session 2009-10 subject to the fulfillment of the following terms and conditions. Any infringement/contravention/non-compliance of these conditions may lead to withdrawal of the affiliation. The college is further allowed to offer the following method subjects:- Economics, English, Geography, Mathematics, Physical Science, Life Science, Commerce, Bengali and Computer Education.

Conditions:

- The college library needs to be furnished with more books and professional journals.
- 2. Appointment letters of teachers with specific scale of pay as well as the acceptance letters of those selected for the faculty are to be submitted to the affiliating body.
- 3. Procurement of proper equipments as per syllabus for Physical Science, Life Science, Geography and Computer Education has to be ensured. Copies of duly filled up stock registers to this effect have to be submitted to the University.

- Terms and conditions as mentioned in the recognition letter of NCTE no. Ref. No. 89-910/2009 dated 22-10-09 of the NCTE be complied with.
- 5. The college must admit students strictly on merit basis.
- 6. The college authorities should abide by the provisions of the C.U. First Statutes, 1979 as existing, proposed and as will be amended from time to time in regard to self-financing colleges/institutions and also existing regulations, notifications and orders or as may be promulgated from time to time by the University or the Government of West Bengal in the case of the college.
- 7. College authority on receipt of the affiliation letter is to submit a report of compliance of conditions as stated above at the earliest.
